

SGA 2021 Elder Board Report

Rev. Perry Friesen Chairman of the Board of Elders

For the last year, I have served as the chairman of the Board of Elders. In 2021, along with myself, Pastor PK Au and Pastor Ryan Wang, the elder board consisted of: **Peli Tam, Don Yang, Raymond Li, Telson Cheung, Gary Cheung, Gerald Tseng, Al Tan, Kei Gee and Wilbert Yee.** Wilbert Yee served as board secretary; Raymond Li served as Treasurer; Gary Cheung was the Human Resources elder; and Gerald Tseng was the Mission elder. We also invited Andy Chan to serve as an elder in training, which allowed him to be part of meetings to observe and learn, but without the privilege of a vote. I want to thank each of these men for selflessly volunteering their time to lead in a challenging year.

Covid still impacts

Although the first lockdown in the first wave of Covid hit in March of 2020, we lived through the past year with continuing impacts from a world-wide pandemic. We entered 2021 at the end of the second wave, but the third wave began right after Easter in April. We shut down in-person services in all 3 congregations. We often held elder board meetings by Zoom. We held our Annual General Meeting in person on March 21, 2021 with 63 people in attendance. We took down our Plexiglas shields on the sanctuary stage before summer. We opened our church to in person services in the fall, but the fourth wave was happening. Since the fall of 2021, all congregations have continued in-person services and online streaming. This is our new reality.

Mental Health Educator

In February of 2021, the SGA board affirmed Dr. Harry Zhou as a Volunteer Mental Health Educator. He can be accessed as an advisor of mental health resources through any of our congregational pastors.

Community Partnerships

By the fall of 2021, most of our community partner rentals re-engaged with us. Evergreen-Shawnee Daycare has grown and plans to expand the number of rooms it rents in 2022 for the first time since being shut down by Covid in March of 2020. The Brazilian congregation, 2 or 3, has actively continued to meet on Thursday nights and Sunday nights in our facility.

A Russian language and culture group rents our facility on Saturday mornings, as does a Burundi language and dance group. Strong Art School rents rooms on Tuesdays and Thursday evenings and Saturday afternoons. We also open our facility to a fair number of piano recitals throughout the year.

Giving

The most important thing I can say about SGA's giving in 2021 is that, despite all the challenges of Covid-19, our giving exceeded our expenses so we ended the year in a net surplus position. Our combined income of donations and rentals, including love offerings, was almost \$1.2 million, and our surplus income (income above expenses) for 2021 was \$323,231! Praise God! This is a testimony to God's faithfulness and the faithfulness of God's people in a very challenging year. You honored God with your offerings and excelled in the grace of giving.

Mortgage Bonds

In 2021, the board voted to create mortgage bonds. \$700,000 in bonds were fully subscribed. This has been managed by Peli Tam, and the board voted again in November to continue the issuance of bonds. So, though we have mostly eliminated our debt to the District, we still have mortgage obligations to our members. With each year that we continue to keep our expenses below our income, the amount of mortgage bonds will be reduced. We should maintain our goal to become debt free.

Pastoral changes

In January of 2021, we welcomed Pastor Esther Boschmann to our Mandarin ministry. In June, Pastor Ryan Wang submitted his resignation effective December 31, 2021. The Cantonese pastoral search committee, led by Telson Cheung, was successful in finding a new lead pastor of Cantonese ministries, Michael Mok. He and his family won't join us in person until 2022. Pastor Kelly Ens became a part-time associate in English ministries in May. In March, we said goodbye to Jacey Zhang who served faithfully as office administrator for many years, and welcomed Oran Chan as a new office administrator. Those are quite a few changes for a small staff in one year!

Bylaw change

Our church members voted twice on the issue of establishing term limits for elders in 2021. The first vote was at our March 21, 2021 AGM. The motion passed, but we only later found out that the Alberta Societies Act had changed the required threshold for bylaw changes. We asked our members to vote again at our November 2021 meeting, and the motion was passed again. So now, "The combined consecutive terms of an elder shall be limited to a maximum of 6 six years. He is welcome to re-join the board if re-elected after the sabbatical year."

Building Improvements

Eric Tsang, Deacon of Exterior Maintenance, helped to facilitate some paving and crack filling in our parking lot. The work was finished by the end of summer before our congregations returned to in-person services.

Over the summer, we replaced our soundboard with a new digital soundboard, a Behringer X32, which is more configurable to meet the needs of each congregation and our Brazilian partners. There was a large team that worked on the implementation of this and we are grateful for each person who invested time into this changeover. The old soundboard was donated to a sister Alliance church who was affected by a fire in 2021.


2. Overall Cantonese Congregation

- a. The following congregants or direct family members went to be with the Lord in 2021:

 - vii. Danny Wong on Jan 6 2022 in Edmonton
- b. Mrs. Wong Chung K, and her daughters Helen and Shirley relocated to Surrey in BC.
- c. Wai Fong Cheung, Tiffany Chow, Jenny Fung and Ng Fong were baptized on Jan 2, 2022; Danny Wong was baptized by Pastor P.K. officiating / Helena Ng sprinkling of water in Edmonton on Aug 4 2021.
- d. By God's grace, we continue to have people baptized, some newcomers attending our service / fellowship. However, under the prolonged pandemic situation, spiritual health of congregants is impacted. Our ability to make connection with newcomers, fellowship among brothers & sisters, and discipleship are also weakened. To partially offset these challenges, we have launched a number of major online events to provide support to the congregation and outreach to the outside people. These online events are highlighted in respective sections and the details are depicted under section 8.

3. Worship/Prayer

a. Sunday Service

- i. The combined online and in person service attendance in 2021 is depicted in the graph below.
- ii. It is encouraging to see that the peaks in attendance have increased to about 700 as we get close to year end, but obviously the peaks are driven primarily by viewers outside of Calgary. This means that the online service has helped us spread the Word of God to a much broader audience., Nevertheless, the number of attendees in Calgary seem to be around 200 or lower (the valleys in the attendance graph). In fact, for some of those attending service online, they might not be worshipping the Lord with full attention.
- iii. The online service has also been presenting a major challenge to us from time to time. While new soundboard has been installed, different congregations have varying AV strategies and requirements.



b. Church prayer meeting

 There are about average 20 participants in the online church prayer meeting every Wednesday. The prayer meeting continues to be a key driver and stabilizing element in the overall congregational momentum.

4. Apprenticeship

- a. With Rev. Ng's Bible study material development and guidance, the cell groups have finished studying Ephesians and are in the process of studying Romans.
- b. Online joint Sunday school class started in June 2020 and covered various special topics in the Bible as well as in discerning cults, other religions and secular culture. Teachers include Pastor P.K., Kin Wai Cheung and Jacqueline Ngai.
- c. "Manna" Bible study guidelines that began in 2012 have been done for the whole Bible (66 books) by Sep 2021. We're in the process of putting the study guides for the whole Old Testament into a single file / hard copy for easy use in future.
- d. Two Bible study groups are held, one on Sunday (Acts of Apostles) and one on weekdays (Gospel of Luke) with the primary objective of reaching out to seekers and following up on new believers.

5. Relationship

a. Cell group

- The cell group meetings resumed in Sep 2020 after overcoming technical challenges. The attendance is more stable than before, and some groups have moved their meeting to different time slots.
- ii. While we look forward to meeting in person, the online meeting seems to have resolved our on-going facility constraint.
- iii. To enhance deeper fellowship and discipleship, a monthly 15-20 min video "247 series" has been given by Wai Kin (video edited by Stephen) so cell group members could view them before discussing their real life application and experience in the cell group meeting. This is in addition to the twice a month Bible study guided by Rev Edward Ng.
- iv. A new believers cell group is being formed end of 2021 for the newly baptized. This group is led by Helena Ng and Miranda Tam, with the study material supported by Kin Wai.

b. Outside of cell groups

i. The caring for brothers and sisters who are not in the cell groups is challenging and ad hoc as they are usually not tech savvy.

c. Outreach

- During the pandemic, OCT teams have been instrumental in keeping the nonbelievers and new believers associated with SGA in contact.
- ii. A number of outreach online programs have been launched with both our brothers and sisters as well as non-believers in mind: these include

testimonies given by Mary Cheung (recovered from Covid), and Pastor Benson (battling through cancer), medical workshop given by Dr. Daniel Ho, Christmas music program. More online programs have been planned for 2022.

iii. 'Kingdom Work' - In light of the pandemic, our annual involvement in OCC stopped in 2020. In response to the OCC's need for help, a group of 9 brothers & sisters formed a group and participated in a warehouse shift in 2021.

6. Missions

- a. Online sharing with missionaries.
- b. Monthly Missions newsletters being sent out by Gerald and Kitty Tseng.
- c. Due to pandemic, there was no Short Term Missions in 2021.

7. Young Adult Ministry (Pastor Philip)

- a. Family ministry:
 - i. Meeting continues to be held online through zoom. The group currently meets on the 1st and 3rd Saturday every month.
 - ii. Topics primarily related to spousal relationship and applying the Word of God to daily life.
 - iii. The prolonged pandemic has affected brothers and sister's commitment in attending the online fellowship program, hence, it will be vital to strive for a sustainable relationship in 2022.
- b. Hong Kong Immigration and Returning Emigrants ministry:
 - i. Workshop
 - Co-hosted job searches and benefits workshop with Immigration Service Calgary (ISC)
 - 2. Co-hosted an emotional health workshop with Chinese Christian Mission (CCM)
 - 3. Co-hosted an immigration workshop with Deacon Immigration
 - 4. Invited Dr. Clifford Pau to host a workshop on children dental care

ii. Special Events

- 1. Mid-Autumn "Good Atmosphere"
 - a. Excluded internal helpers, there were 94 guests signed up for the event, with 48 guests or 51% were new to SGA
 - b. The event was cancelled due to the concern on the spread of covid-19 Delta variant. On the surface, it seems to be a set back, but we have achieved the primary target of getting connected to HK newcomers in Calgary.
 - c. As part of the follow up, we have distributed 23 Mid-Autumn festival gift baskets which includes a mooncake, a candy bag,

and a booklet that contains all the advice / tips from our beloved brothers and sisters to our new guests.

- 2. Jesus' Birthday Party
 - a. To bridge Cantonese Children Sunday School parents with Zoe Family, the Hong Kong Immigration and Returning Emigrants Execution Committee was in favor of holding an in-person special event on December 18.
 - b. 78 people attended this event, with 32 newcomers (19 adults and 13 kids).
 - c. Special thanks to SGA members: Telson, Sing, and Lina for facilitating the event in children ministry trailer.
- iii. Cantonese Online Children Sunday School (K-6): 28 students enrolled, with average attendance of 20 students.

- 9. Missionary Ministry: Due to the pandemic, there were no short term team mission trips in 2021. However, in July, we invited Rev. Dick Kaan, a missionary in Europe, to share twice. Our congregants were engaged and learnt a lot in the Q&A session.
- 10. Baptism and Membership Transfer: This year baptisms were in July and November. The newly baptized are Richard Kong, Xiaobin Song, Dapeng Zhang, Lei Shi, Stephen Shi. There are six membership transfer: Yanxiao Wang, Wei Jiang, Xuehan Qing, Yuqin Chen, Lucy Lu and Edward Wang.

With courage and God's leading, Mandarin Ministry are moving forward steadily even with the pastoral changes. We hope that through different activities especially ESL course, we can help the Mandarin attain CLB level 8 or above so that they can advance their studies. We also hope that with the end of Covid rules, we can outreach to more non-believers, bring them to the church and praise and celebrate God together! Amen!

2021 English Ministry Report

Our mission statement: to be 'a house of prayer for all nations and a church that goes to all nations.'

Worship through Covid

For the first three months of 2021, our worship services were online only because of the second wave of the Covid pandemic. We reopened on Easter Sunday in April, only to close again after a couple of weeks because of the rising third wave. We had a



couple of events together in the summer, but in the fall returned to in person services for English worship and children's ministry. Our **average attendance** for four months in the fall was **71.** I've been encouraged that we have some new families that have joined us in person, in spite of the pandemic around us.

In the winter season, we moved through The Story, which took us on a journey of the important stories of the Old Testament and New Testament. In the Spring, we reflected on God at Work and the Rest of God, a Sabbath series. In the summer, we studied the beloved book of Ephesians. In the fall, we focused on a series called Know what you Believe – a topical study of the important doctrines of our faith.

We continue to Livestream our services and make them available to watch on demand any time throughout the week. We have 66 Youtube subscribers, and the number of views on any given Sunday range from 50 to 150. I'm especially thankful for Janny Quan who served tirelessly for much of 2021 to record worship songs and preaching and put them together in post video editing.

I'm grateful for Chelsia Tung, Deacon of Worship ministries, who continued to encourage our worship leaders to grow in skills and worship passion. Thank you also to Lincoln Chow, Corliss Fung, Janny Quan, Tim Tsang, Alvin Chan and Wilbert Yee who support our services not just live in the sanctuary, but also make them live streamed on our website and recorded so they can be watched on demand. One area 2020 helped us grow in was our AV capabilities.

Most of our home groups have continued to meet through Zoom, but occasionally they meet in person. There is a desire to see each face-to-face, even with a mask on. Our home groups have also learned to meet by using Zoom technology. We connect with God and each other, for mutual encouragement through the Word and to pray for one another.

Helping children, youth and adults become fully devoted followers of Jesus is a core reason why we exist.

Children's Ministry

During Covid, many children's ministries in Calgary just offered videos online, but no personal contact with children. I was very proud of Pastor Sham and her children's team. They maintained classes with personal contact throughout Covid isolation. Sham delivered resources to the children so they would have all the papers, crafts, scissors and crayons they needed to follow

the lesson and learn creatively. Doing children's ministry on Zoom is challenging, but they were up to the challenge.

Youth Ministry

The vision of youth ministry is: "Helping our friends take one step closer to Jesus every day." Read Pastor Matt's report for more details about youth ministry.

Young Adult ministry

Kelly Ens began ministry with young adults on a part-time basis beginning May 1, 2021. He brought a wealth of experience to our young adult ministry. First, he met with many of the young adults individually in order to get to know the needs in the group. He met with those serving as leaders and helped breathe new life, focus and energy into the Anastaino and Young Adult groups. You can read more about the RE-Start of that ministry in Pastor Kelly's report.

Missions

On October 8, 2021, Kate Tan was approved for a non-portable license with the Christian and Missionary Alliance. She is planning to go to Thailand as a missionary apprentice, and I'm so excited that we get to do more than just give money to the Global Advance Fund; we get to send her out as one of our own.

Serving

I want to thank the English elders for their service in 2020: Kei Gee, Al Tan, and Wilbert Yee. Thanks to Lynda Friesen, Tom and Polly Chin, Ruth Chiu and Barry Poon for faithfully leading our Sunday morning prayer times, and for each one who volunteers to be on the prayer team ready to pray for people. Thanks to everyone who leads home groups well. It was a challenging year to move from in person gatherings to trying to lead, develop community, and grow by Zoom. Thank you to Elton Chan who welcomes us. Thank you to Todd Warnick for serving as a communion deacon. Thank you to Kei Gee, Barry and Esther Poon, and Marilyn Tan who serve hidden away as finance counters.

Baptism and Church Membership - +11

On July 11, 2021, we had **two young people baptized**: Meghan Lee and Shirly Fan. It's always a highlight of ministry to see people commit their lives to follow Jesus.

In addition to welcoming Meghan Lee and Shirly Fan as new church members, we also accepted **9 new members** through transfer. On September 5th, we welcomed Kelly and Jen Ens, Emma Salameh, Roger Luo, Joshua Leung, Harry Zhou and Nancy Yang. On November 21st, we welcomed Enoch Tsui and Samantha Lim.

Looking forward

As I look to the future, I hope we will continue to dream about the things we can do as a church in our community. Let's reach out to serve and love the lost. Let's be ready to receive new people whose hearts have been changed by the Gospel of Jesus Christ. Let's keep imagining what God can do and asking God to pour out His Holy Spirit on us.

2021 Young Adult Ministry Report

Pastor of Young Adult Ministries

The Summer/Fall of 2021 was a new beginning for our Young Adult Ministry at South Gate Alliance. Tired and weary from the pandemic, and meeting on-line, Anastaino (mostly college aged) and Life Groups (mostly 25-35 year olds, who are single or married without kids) were ready for a fresh ministry RE-Start!

After being hired part-time in May, the majority of the Young Adult Leaders and I met in June to discuss how to provide meaningful opportunities for connection, promote active participation from group members, and ensure a sustainable ministry for the leadership. Together we made 3 significant changes to our Young Adult Ministry that were implemented in the Fall.

First, we changed the Meeting Day for each group. In the past, Anastaino, Life Groups, and our Youth Ministry all met on Friday Evenings ... making it impossible to be a leader in one ministry, and still connect weekly with your peers in another ministry. So, our first task was to switch the meetings times for both groups. Beginning in Sept 2021, Anastaino began meeting on Tuesday Evenings (which changed to Monday Evenings in 2022) and Life Groups began to meet on Wednesday Evenings. The hope going forward is that this will allow members of Life Groups to serve in Anastaino, and allow members of Anastaino to serve in our Youth Ministry with Matt.

Second, we changed our monthly schedule. Instead of just meeting in small groups every week, we sought to offer some variety to our meetings that would provide consistent opportunities for connection, and service, and fellowship, and growth. And so both groups agreed to a new 4-week rotation, involving two small group evenings a month, one large group evening (*led by me*), and one connecting or service event per month, where members would feel safe inviting their unchurched friends to the group.

And third, we agreed that we needed a Young Adult Prayer Team. James 5:16 tells us that prayer is powerful and effective, and so we wanted a group of prayer-partners who would pray regularly for the ministry. A team to intentionally intercede for the shared needs of specific members, but even more importantly who would pray for the group's spiritual health; for discerning the Spirit's leading, for obediently responding to the Spirit's promptings, that new people would be drawn to the groups, and that we would see Life Change! And in September we launched our new Prayer Team.

And as a result of these changes, we now have a Young Adult Ministry with a more balanced leadership structure, where many individuals are contributing to the community! Samantha and Corliss are our Anastaino Leaders, each facilitating a small group. In Life Groups, Enoch oversees a "shared-leadership" small group, while Josh leads a discipleship huddle, that seeks to discern God's promptings, and follow thru on those promptings, in spiritual partnership. Our Prayer Team features Kate, Janny, Maddy, Claudia, and Chelsia, who meet bi-weekly to intercede on behalf of the group. And then Tim, Sam, Claudia, Christina (and sometimes others) form our Event Team to help plan monthly connection events that promote community, and sometimes service opportunities ... such as our Kick-Off BBQ in Sept, our Laser-Tag showdown in Oct, our Worship Night and our Operation Christmas Child Service Events in Nov, and our XMAS Party in Dec. And finally, Heather and Sam keep us all up to date, week-by-week, with their wonderful administrative gifts!

Overall it has been healthy RE-Start for our Young Adult Ministry, but we expect and hope this

coming year will continue to be a time of transition and growth. Please pray for us, for new ministry initiatives, and for wisdom as we contemplate how to best organize ourselves, that we may provide the most helpful culture possible to experience Christ's transforming work in our Young Adult Community.

2021 Youth Ministry Report

In 2021, the vision Emmaus continued to be, "Helping our friends take one step closer to Jesus every day." The goal was to develop a fellowship of believers that supports each other both when we can meet and when we cannot.

Our world saw a 2nd year of doing ministry differently compared to what we grew up with. We were accustomed to in-person, face to face, multiple meetings in a week, singing loudly in tight spaces, huddles with hugs, tears and intimate prayers. This year, we met as much as possible, but spent much of our year online. In 2021, we became less program centered and more relationship focused. It was a blessing as we returned to a value of Jesus where he met with people and spent time with them instead of setting up a program that broadcasted information with limited personal connections. We moved from a ministry that wasn't centered on Friday and Sunday program and events, and into a fellowship learning to care for each other by walking with Jesus together any day and at any moment. It is like walking with Jesus together, like when two disciples were walking together on the Emmaus Road and Jesus walks alongside them.

Luke 24:14-15 - They were talking with each other about everything that had happened. As they talked and discussed these things with each other, Jesus himself came up and walked along with them.

To do this, we had to start with a strong team of young adult leaders so we can effectively delegate the pastoral ministry. Throughout 2021, we had Alvin Chan, Matt Cheung, Jon Chin, Chris Chiu, Vennessa Lee, Karlene Lee, Kelvin Lee, Charmaine Ma, Brittany Mah, Kate Tan, and Sharmaine Tay. I'm so pleased to work with every single one of these young adults and be a partner in ministry with them. They have helped me grow as a pastor and leader, and they have changed the lives of the youth that they were overseeing and pouring life into. Without each of them giving through their gifts, this would be a blank page. My friends, I thank my God every time I remember you. In all my prayers for all of you, I always pray with joy because of your partnership in the gospel from the first day until now being confident of this, that he who began a good work in you will carry it on to completion until the day of Christ Jesus. (Philippians 1:3-6)

Youth ministry has taken a turn to be more online than in person. We have various social media platforms that we use to increase interaction. Our goal was to return to the biblical value of meeting as often as possible, but now online and supporting each other in hobbies, education, friendships and faith. With this focus, it was less about having an event, which was always difficult over Zoom, and more about the ongoing relationships throughout the week.

The ministry events that the team had put together were amazing. The year was marked by these meetings:

- •Relationship Panel Online with adults from many different relationship stages and walks of life
- •Lent Event Study on the Fruit of the Spirit throughout Lent from many people in our church, culminating in an in-person retreat at the church
- Family Night Online Spaghetti Cook and Dinner
- •Grad Night Online with 11 youths graduating into adulthood
- •Spontaneous worship and firepit evenings at the church
- •Emma Us Our homemade Zoom versions of Among Us

Our small group ministry was the largest portion of youth ministry with two major directions. In the first half of the year, we continued and finished The Story, an abridged reading of the Bible outlining God's story, and then n September, we moved into Activated Faith which focuses on living out our faith actively. We have seen our youth grow, mature into young men and women who follow Christ because of these topics as well as the Christ centered fellowship experienced in each small group.

Overall, this year was challenging in re-learning how to live as a fellowship centered on Christ. Being a part of each other's lives while not just socially distant, but physically not seeing each other as regularly as we used to is difficult, yet those who were willing to commit to faith and fellowship grew. I hope that in 2022, we would see the Lord's blessing many times more!

"The combined consecutive terms of an elder shall be limited to a maximum of 6 six years. He is welcome to re-join the board if re-elected after the sabbatical year."

Motion: Perry. Seconded. Passed.

When does the 6-year term limit start for Elders? The 6-year term limit starts in 2021 for Elders. We cannot start it retroactively start.

(Post Script: After submitting the proposed by-law change to the District, it was discovered that the threshold for bylaw changes should be 75%. The vote on this issue was perhaps less than that, (45/63 or 71%) so the bylaw change was not enacted by the District, and consequently, our elder board withdrew the request for the bylaw change.)

Have we considered returning the money to the government since we have been blessed? (Post script: This idea was passed on to the Elder board for discussion on April 13th. The elder board has no current plan to try to return the money to the federal government. We are evaluating other directions for investment of that money.)



1. STATEMENT OF PURPOSE

South Gate Alliance is a member church of the Christian and Missionary Alliance in Canada which is an evangelical Christian denomination, providing worship services, education and fellowship to its congregation and others in the community.

The church is incorporated under the Societies Act of Alberta and a registered charity under the Income Tax Act, as such is exempt from income taxes.

2. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared in accordance with generally accepted Canadian accounting principles for not-for-profit organization in Canada, using the assumption that the organization will continue as going concern.

Significant accounting policies are described below:

2.1 Accounting Changes

The CICA has issued a new accounting framework applicable to Canadian not-for-profit organizations. Effective for the annual reporting period that commences on or after January 1, 2012, not-for-profit organization has to choose between International Financial Reporting Standard ("IFRS") and Canadian accounting standards for not-for-profit organizations, whichever accounting framework suits them best. The church has decided to adopt Canadian accounting standards for not-for-profit organizations and does not anticipate a significant impact to its financial statements.

2.2 Fund Accounting

The church follows the restricted fund method of accounting. Contributions which are designated by donors are accounted for as restricted and expended according to donors' specifications. Restricted funds included mission funds and other restricted funds. Other contributions are accounted for as unrestricted and are expended at the discretion of the Board which include but not limited to program delivery and administrative activities.

The Missions Fund receives contributions and reports activities with respect to global mission, district operation, Canadian ministries, mission projects and support of missionary undertaken by the church.

Unrestricted Fund is a general fund in nature to cover all other operation, programs and activities of the church.

2.3 Revenue Recognition

Revenue from contribution is recognized when received.

Revenue from interest and other is recognized in the period to which it relates and is included in the unrestricted fund.

2.4 Property, plant and equipment

Property, plant and equipment are recorded at cost. Depreciation is not recorded. Contributed capital assets are recorded at fair value at the date of contribution.

2.5 Contributed Services

Volunteers contributes a significant number of hours each year to assist the church to carry out its services and activities. Because of the difficulty in determining the fair value of contributed services, they are not recognized in the financial statements.

2.6 Use of Estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from the estimates.

2.7 Going Concern

The church adopted the requirements of the CICA Handbook Section 1400, General Standards of Financial Statements. The additional requirements require management to make an assessment of the church's ability to continue as a going concern, and to disclose any material uncertainties related to events or conditions that may cast significant doubt upon the entity's ability to continue as a going concern. The church does not anticipate any negative impact to its financial statements arising from the adoption of the accounting pronouncement.

3. FINANCIAL INSTRUMENTS

The church's financial instruments consist of cash, a term deposits, Goods and Services Tax recoverable, and accounts payable.

It is management's opinion that the church is not exposed to significant interest, currency of credit risks resulting from its financial instruments.

Carrying value of financial instruments approximates market value.

The church registers its land and building in the name of The Western Canadian District of The Christian and Missionary Alliance in accordance with denominational practice. This practice results in the church being able to negotiate favorable financing terms on a collective basis under the master lending agreement between the Western District and the bank.

No depreciation was booked in all property, plant and equipment and obsolute equipment is written off (Note 2).

5. Impairment of Long-Lived Assets

Long-lived assets are tested for recoverability whenever events or changes in circumstances indicated that their carrying amount may not be fully recoverable. An impairment loss would be recognized when and to the extent that the carrying value of an asset exceeds the total undiscounted cash flows expected from its use and eventual disposition.

6. Management of Capital

The church's objective when managing capital is to ensure it has adequate cash flow to maintain operations and fund capital projects. In the management of capital, the church includes long-term liabilities and fund balances as the definition of capital. At December 31, 2021, the church has \$7,025 long term liabilities and has fund balance of \$6,021,748 (2020 - \$5,698,520).

In August 2021, the churrch has issued \$700,000 bond (140 units) with 1.5% interest rate; at December 31, 2021, \$450,000 (90 units) are still remaining in the account.

7. RELATED PARTIES

The church is a member church of The Christian and Missionary Alliance and part of The Western Canadian District.

During the year, the church paid \$10,750 (2020 - \$18,500) and \$10,750 (2020 - \$3,000) to the district for District Operating Budget and Canadian Ministries respectively and \$53,000 to the national organization for Global Advance Fund (2020 - \$78,628).

8. PENSION COSTS

Certain employees of the church are members of a defined contribution pension plan operated by the Christian and Missionary Alliance. During the year, the church contributed \$23,567 (2020 - \$19,589) to the plan. As a plan is defined contribution plan there is no potential for a contingent liability.

9. INCOME TAXES

The church is a registered charity and not subject to federal and provincial income taxes.

10. COMPARATIVE FIGURES

Certain accounts in the prior year financial statements have been reclassified for comparative purposes to conform to the presentation in the current year's financial statements.
